If any debit to CUSTOMER'S account should fail to be honored by BANK due to insufficiency of available funds or account closure, COMPANY shall be entitled to recover from CUSTOMER all fees and charges imposed by BANK by reason thereof and CUSTOMER shall forfeit any discount of other allowances applicable to the transaction(s) giving rise to such dishonor. Any such occurrence of dishonor may result in termination of CUSTOMER'S credit. All credit and other terms and provisions between CUSTOMER and COMPANY shall remain in full force and effect. If returned fees are not paid in full by EFT or other means as instructed by CUSTOMER, within 10 days of the original return date the COMPANY reserves the right to redraft any unpaid balances in part or in full at their sole discretion.
